2. Licensing/permitting information. Peter Huffman provided a brief summary on the current requirements for licensing and regulation. He announced that the Planning Commission will continue its work as outlined in the moratorium ordinance at 4 p.m. on the first Wednesday of the month.
3. Facility/Group Home inventory. Corinne Dixon and Phillip Brooke provided additional information on the location of facilities on the North Slope and the Hilltop.
4. Work group reports: behaviors. Marty Campbell reported on the work group that developed definitions of high risk and high needs residents using the Comprehensive Plan as a starting place. Phillip Brooke reported on the work group that developed listing of behaviors of high risk and high needs individuals, service providers, housing providers, government agencies, and police. Staff will combine the behaviors.

5. Techniques: Members identified additional techniques under the first four categories and volunteered for work groups during the next meeting. Members suggested combining the homeownership and rental housing
